

**CIRCULAR**  
**FOR**  
**EMPANELMENT OF ENVIRONMENT AUDITOR/ CONSULTANT &**  
**ANALYTICAL LABORATORY**

To ensure compliance of the objectives and provisions of the Water(Prevention & Control of Pollution)Act,1974, Air(Prevention & Control of Pollution)Act,1981 and Environment(Prevention)Act,1986 and related rules, the Rajasthan State Pollution Control Board invited applications from experienced and expertise agencies, Government /Semi Government organizations, Engineering Colleges, Laboratories and personals for their empanelment with the State Board for undertaking Environment Auditing, compliance monitoring, environment impact assessment, surveys for assessment of pollution load in various sector/areas, sampling and analysis of water, air and hazardous wastes and Environment studies. The expert team of the State Board examined and considered the submitted information of these agencies during their presentation held on dated 7 & 11<sup>th</sup> August,2009. The following conditions shall be complied by the empanelled Auditor/Consultant & Analytical Laboratory

1. That the empanelled auditor/consultant shall submit the yearly details of the work /assignment carried in the State by 30<sup>th</sup> of the April of the next year (April - March).
2. That the State Board shall have right to de-list/de-empanel any of the auditor/consultant without prior notice.
3. That the empanelment shall be reviewed after every two years.
4. That the empanelment by the State Board shall not be treated as approval of the Board to assign any project related with environmental monitoring, auditing or impact assessment.
5. That all the conditions contained in Notification dated 20.05.09 shall be applicable upon the Analytical Laboratory.


